\_\_\_\_\_ **Single Family Dwelling Unit:** **In all cases, submit copy of plot plan and Planning Board Resolution.** Construction of a single family dwelling unit which is not part of a proposed subdivision, planned development or construction permit application involving 2 or more single family dwelling units.

\_\_\_\_\_ Construction of a single family dwelling unit on any lot that has arisen from a subdivision approved after January 1, 1976 that did not create two or more buildable lots and the proposed cumulative land disturbance is less than 5,000 sq. ft.

\_\_\_\_\_ Construction of a single family dwelling unit on any lot that has arisen from a subdivision approved prior January 1, 1976 where I do not own or plan to build more than one home at a time.

\_\_\_\_\_ **Agriculture:** Cultivation of land for the production of food, fiber, animals and related activities customary to agricultural production and operations. This applies only to crop cultivation and not to the construction of agricultural structures. **Submit copy of USDA-NRCS Farm Conservation Plan.**
